g) a Person under the age of 18 that operates a Temporary or seasonal business for the purpose of preparing goods for consumption by the general public or offers residents or businesses maintenance or services and receives remuneration or reimbursement for product costs;	
h) a Person that provides occasional services as an act of goodwill where they may receive remuneration in kind for their services and reimbursement for product costs; and
