



# 2024 Recreation Inclusion Program

The City of Beaumont will subsidize individuals and families who demonstrate an inability to pay for programs and services that would contribute to their personal growth and community involvement.

### Subsidy Options

1. General application: \$150 per person, per calendar year
2. Assured Income for the Severely Handicapped (AISH) application: free access to applicable programs and services

### All Applicants

- Open to residents of Beaumont
- Applicant must fill out the following application form
- Funds must be used by December 31 in the calendar year in which they were received
- Applicant must apply annually
- Funds are on a first come first served basis, depending on the allocated yearly budget
- The decision of the City of Beaumont is final

### Beaumont's Programs and Services Include

- Registered Programs: swim lessons, fitness classes, art and performing classes
- Beaumont Sport and Recreation Centre: memberships, drop in admissions, punch pass, child mind

To qualify for the program subsidy, individuals or families must meet the following income criteria:

### Income Verification

Please provide ONE (1) of the following requested documents for all adults in the household. If more than one applies, select whichever is the easiest for you to verify.

- I am on Assured Income for the Severely Handicapped (AISH) / Income Support and have a Monthly Paper Alberta Health Benefits Card. (Please provide a current copy of your AISH / AHB Card.)
- I have a plastic Alberta Works Health Benefits Card. (Alberta Works sends a letter each year to renew the plastic card, rather than sending a new card. We require a copy of the renewal letter with a specific expiry date (cards provided during training do not qualify as verification documents for this program.) If you do not have the letter, please contact Alberta Works to request a copy of the letter at 780-644-9992.)
- I am providing my Income Tax Notice of Assessment (NOA). (Please provide a copy of the current Income Tax Notice of Assessment showing Line 150.)
- I am providing two (2) recent paystubs.

- I am a new Immigrant and have a Confirmation of Permanent Residence or a Refugee Protection Document. (In order to be considered a new immigrant for our program, you must not have been eligible to file taxes for the previous year, your submitted documentation must be less than one year old AND you must have been in Canada less than one year. Please provide a copy of the front and back of the PR Cards for each family member, OR your Confirmation of Permanent Residence paper listing each family member OR your Refugee Protection Claimant Document.)

## Proof of Residency

Please provide ONE (1) of the following requested documents to verify your current address. The document may be in either your or your partner's name. We cannot accept identification cards, driver's licenses, or tenancy agreements. The name and address must match what is listed on the application form and must be the current physical Beaumont address.
