### FIRE PIT REQUIREMENTS & RESTRICTIONS

1. Fire pits, barbeque structures or outdoor fireplaces shall be located a minimum of 3m (10 feet) from anything combustible (including buildings, fences, trees, etc.)
2. Fire pits shall be located on the site in an area that takes into account the normal wind direction to prevent smoke from bothering the neighbours.
3. There shall be no burning of grass, weeds, leaves, garden refuse, tree limbs, garbage or similar materials in a fire pit, barbeque structure or outdoor fireplace.
4. When in use, the fire pit shall be at all times attended by the property owner/occupant, who will be held responsible for any damage and costs resulting from the use of a fire pit, barbeque structure or outdoor fireplace.
5. Fire pits shall be made of base and sides that are non-combustible.
6. Fire pits shall be no greater than 32" (81.2cm) in diameter and a minimum of 12" (30.5cm) deep and there shall be a fire screen to contain sparks over the fire at all times while burning (for example, a spark arrestor mesh screen of 1/4" (7mm) expanded metal or equivalent).
7. Outdoor fireplaces (including Chimeneas) may be placed on a concrete patio, but they may not be located on decks.
8. The applicant is responsible for booking an inspection with the Beaumont Fire Department after construction is complete.

Where an emergency or potential emergency exists, or due to hazardous weather conditions, the Fire Chief or designate shall be empowered to suspend all outdoor fires or any outdoor fire pit for cooking or warming purposes, other than those fuelled by propane or natural gas, within City limits for such a period of time and such conditions as may be determined by the Fire Chief or designate
