# **CITY OF BEAUMONT PET LICENSE INFORMATION**

## **SECTION 1 - LICENSE REQUIREMENTS**

The City of Beaumont Animal Control Bylaw requires that every dog/cat (pet) reaching the age of six (6) months and over must be licensed prior to January 31st of each calendar year or the owner faces a fine of \$250. No more than three each of either cats or dogs or a total of four (4) cats and dogs combined, are allowed per household. Please note the following excerpts from the Animal Control Bylaw #851-15. (A complete copy of the bylaw may be obtained on request from the City Office.)

- Running at Large: (\$100 fine, first offence) No owner shall permit his/her pet to run at large. "At large" an animal off of private property and not on a leash held by a person able to control the animal.
- Barking/Howling: (\$250 fine, first offence) No owner shall permit his/her pet to bark/howl excessively in a manner as to disturb a reasonable person.
- Defecation on Public or Private Property: (\$250 fine, first offence) If an animal defecates on any public or private property other than the property of its owner, the owner shall cause such feces to be removed immediately

### **SECTION 2 - FEES**

Pets must be licensed each year and renewal fees are due February 15th of the current year. Payment can be made by cash, debit, or cheque. We do not accept credit cards or e-transfers.

### Licensing Fees Are As Follows:

- Senior citizens (65 and older) If you are a senior, there is no charge.
- Neutered/Spayed Pet: \$30.00
- Non-Neutered/Spayed Pet: \$50.00
