


# Regular Council Meeting Notes



April 28, 2020

## **Leduc Regional Housing Foundation Overview (6:34)**

Council received an overview of the Leduc Regional Housing Foundation's role providing supportive living, seniors apartments, community housing, and housing programs in the region, including Beauregard Manoir and Villa Beauregard in Beaumont.

## **Budget Amendment Approval (27:21)**

Council approved amendments to the city's 2020 operating and capital budgets. Notable changes from the budget approved in February included projects carried forward from 2019 and previous years, an increase in forecast assessment growth from 2019, and funding allocated from reserves to the city's COVID-19 response.

## **Cenotaph Planning (40:48)**

Council approved a motion by Coun. Steven vanNieuwkerk directing city administration to identify sources of funding and a location for a cenotaph in Beaumont commemorating the sacrifices of Canadian Armed Forces personnel who served Canada.

## **Regional Collaboration (49:28)**


Council approved a motion by Coun. Steven vanNieuwkerk directing city administration to develop a plan for hosting municipal representatives from the region to share experiences and learnings.

## **Fee Schedule Update (1:12:05)**

Council approved updates to the city's 2020 fee schedule. Changes included new membership and access fees for the Beaumont Sport and Recreation Centre when it re-opens later this year, updating permit fees that had been overlooked in the schedule that was approved in February, and fees that will enable the use of the Beaumont Community Centre kitchen as a shared commercial space.

## **Financing for Beaumont Sport and Recreation Centre (1:27:34)**

Council approved a bylaw to borrow an additional \$2.7 million to fund the Beaumont Sport and Recreation Centre, bringing total borrowing for the project to \$29.35 million. Of the additional amount, \$2.5 million was approved in the 2020 budget to fund furniture, fixtures and equipment for the expanded centre, and \$200,000 will fund construction contingencies.

## **Property Tax Rate Bylaw (1:29:20)**

Council approved a bylaw establishing the municipal and supplementary property tax rates based on the 2020 budget approved in February.

## **Property Tax Penalty Bylaw (1:31:12)**

Council approved a bylaw extending the deadline to pay property taxes without penalty from June 30, 2020 to September 30, 2020. The deadline was extended to provide relief for property owners financially affected by the COVID-19 pandemic.

## **Water and Wastewater Services Bylaw (1:32:50)**

Council approved a bylaw extending the deadline to pay water and wastewater bills without penalty or disconnection to September 30, 2020. The deadline was extended to provide relief for residents and businesses financially affected by the COVID-19 pandemic.
