PURPOSE OF REPORT

The RCMP endeavors to communicate regularly with its Federal, Provincial, and Municipal partners. The purpose of this report is to provide the Town of Beaumont with a quarterly update on any Detachment issues or trends, to provide an update on the progress of our annual policing priorities, and to provide information relative to our crime statistics.

REPORT INTENT AND CONTENT

This report has been designed with input from the Town of Beaumont. This report is not intended to provide a comprehensive account of all policing activities in Beaumont. Rather, it is meant to provide Council with an update on the more salient policing issues and priorities. Requests for additional information or amendments to this report may be submitted through the General Manager of Community and Protective Services.

DETACHMENT COMMENTARIES

OUR STATISTICS AT A GLANCE

The RCMP fiscal year of April 1st to March 31st is different from the Town of Beaumont's fiscal year which follows the calendar year. Therefore, the last quarter of January 1st to March 31st, 2016 is considered the 4th quarter for the RCMP but 1st quarter for the Town of Beaumont. The following represent the RCMP fiscal totals:

- 1. Crimes against persons: For this Quarter, assaults have decreased slightly from 100 in 2014 to 96 in 2015 but uttering threats have increased from 37 in 2014 to 50 in 2015. Overall the numbers of crimes against person's calls for the past five years have the following numbers: 2011: 135 files; 2012: 159 files; 2013: 128 files; 2014: 176 files; and 2015: 208 files. This steady increase may very well have to do with the steady increase in Beaumont's population growth. Victim Services opened a total of 16 files related to violence in relationship files. These sensitive files remain a national priority.
- 2. Property crime: Overall, has remained relatively stable. The past five year results as follows: 2011: 384 files; 2012: 392 files; 2013: 434 files; 2014: 470 files; and 2015: 487 files. This steady increase may also be accounted for by the steady population growth of Beaumont.

NEW OFFICER PLACEMENTS SINCE THE END OF 2015

Our officers are often transferred within the organization to gain different experiences and to meet the changing needs of our communities and/or our organization.

- Cst. Paul Glennie transferred into Beaumont in March with nine (9) years of general duty service. Alberta is his third province after having worked in both Manitoba and Nunavut. Cst. Glennie first worked in Portage La Prairie Detachment in northern Manitoba and then he transferred to Nelson House Detachment in Nunavut as part of the "Relief Team" where he flew into isolated northern detachments around Nunavut to cover for short term absences such as holidays, maternity leave, sick leave, position vacancies, etc. Once he came to Alberta, he worked a short term in Leduc before getting settled down to Beaumont Detachment.
- Sergeant Dhaliwal comes to Beaumont from Leduc detachment as interim detachment commander until the new commander sells his home and can complete his move to Beaumont. Sergeant Dhaliwal is an 18 year member of the RCMP, most recently serving as a Watch Commander at Leduc Detachment. He has experience in both British Columbia and Alberta with a background in General Duty, INSET, Calgary Criminal Intelligence Unit and VIP and Protective Services. He is very familiar with policing in Leduc County and will be engaged in the needs and expectations of the detachment and the Beaumont community. Because of his diverse policing experience, Sergeant Dhaliwal is well placed in this position. He will focus on further development of effective communications; both internally amongst municipal staff and RCMP members and with our external partners. He is very eager to fill this role at Beaumont Detachment and work with the community partners to ensure continued police service delivery, not only to the citizens in Beaumont but also to the detachment employees.

ANNUAL POLICE PRIORITIES UPDATES

Since the RCMP operates on an April 1st to March 31st fiscal year which differs from the fiscal year of the Town of Beaumont, the new annual policing priorities for 2016 are being looked at for the April start-up. The local Community Advisory Committee (CAC), which has a good cross-section of local representatives, had created a survey that was launched via "Surveymonkey", an on-line survey that was advertised for local residents to have a say and help choose three policing priorities out of a list of several. The computer program gathered this information to allow the CAC to see what Beaumont residents really see as important policing priorities. The survey data has been compiled and is awaiting formal approval from the Town Council of Beaumont for the upcoming year. recommended priorities are listed below in this report.

POSITIVE YOUTH DEVELOPMENT

The permanent Community Resource Officer, Cst. Bart Warner, is now in place. He has taken over the Positive Ticketing campaign and is getting ready for a June start-up and a start-up "Launch"

party is being planned for June. This event will be held in June of each coming year and will replace the year-end party. Cst. Warner is also planning a bicycle safety clinic scheduled for June. He is partnering up with the Beaumont Lions Club to host what is hoped to be an annual event to educate the youth on bicycle safety. The D.A.R.E school classes are winding down and will be completed prior to the upcoming school year end.

IMPAIRED DRIVING

This past year was a busy one for Beaumont Detachment's Impaired Driving Initiative. The annual enforcement goal set for impaired driving related charges (including 72 and 24 hour suspensions) was far exceeded by year end. In 2014 the number of charges was 44. The goal of 48 was set for 2015-2016 fiscal year. With the inclusion of the Traffic Safety Initiative for the year, more vehicle stops were made; therefore, more impaired related offenses were revealed. A total of 83 charges (including 72 and 24 hour suspensions were laid.

ILLEGAL DRUGS

The position/job description for the Beaumont Drug Member was rewritten to enhance enforcement abilities for the position. A uniformed aspect to the position was added. Since illegal street level drugs coming into Beaumont is being brought in via motor vehicles, the uniformed aspect of the position is to have the Drug Member actively doing traffic stops in order to locate illegal drugs coming into Beaumont. The Drug Member attended a fentanyl workshop in order to learn of the dangers of this dangerous drug that has been the cause of several drug related deaths across Alberta. The information learned in this workshop was distributed to all the other members of the Beaumont Detachment so the dangers of this drug are known by those who may come into contact with it. A community awareness seminar is being set up to educate the residents of Beaumont of fentanyl's dangers as well. The date, time, and location will be announced for this seminar once it is arranged and residents of Beaumont will be invited to learn more.

2016-2017 PROPOSED POLICING PRIORITIES

The Community Advisory Committee (CAC) created a survey that was put out to the residents of Beaumont for their input into what the new policing priorities should be for the new fiscal year. The survey was subsequently completed by 503 residents of Beaumont where residents chose their top three choices of priorities. The results of the survey are attached to this report for reference. The CAC agreed that the survey would provide a good cross-section and would use the results to propose the priorities to the Town Council. Since domestic violence is a national priority it wasn't included as a choice for the survey.

The results revealed that the top three policing priorities are:

- Impaired Driving (drugs/alcohol)
- **Property Crimes**
- Preventing Youth Crime through Positive Youth Development.

These are what the Beaumont RCMP and CAC recommend to Town Council for approval for the 2016-2017 policing priorities. All aspects of Federal, Provincial, and Municipal statutes will continue to be enforced. Policing priorities are established annually to ensure the RCMP is appropriately addressing, in addition to all calls for service, those policing issues that are identified as the most important to a community. This might mean, for example, realigning resources, implementing targetspecific training, or focusing strategic initiatives. Establishing policing priorities does not mean the RCMP will stop policing or addressing other issues, complaints, or priorities.

2015-2016 policing priorities included: Youth Positive Ticketing, Impaired Driving, and Illegal Drugs. As shown in the report, the RCMP Detachment surpassed/exceeded goals and expectations of the above noted priorities.


DETACHMENT CRIME STATISTICS

This will be the way the graphs will be presented from now on.
