

Provincial Government - Programs

Alberta Seniors Benefit

The primary source of income for seniors (65 years of age or older) is provided by the Government of Canada through the Guaranteed Income Supplement and Old Age Security. To supplement these programs the Government of Alberta provides the following supports and services.

Financial Assistance Programs for Seniors

Alberta Seniors Benefit provides a monthly benefit to eligible seniors with low income to assist with living expenses.

The benefit is determined by:

- Type of accommodation you live in
- Marital/cohabitation status
- Income (combined with spouse/partner if applicable)
- Receiving federal Old Age Security pension

Supplementary Accommodation Benefit

The Supplementary Accommodation Benefit supports eligible seniors who reside in a designated supportive living or long-term care facility with monthly accommodation charges. The Supplementary Accommodation Benefit is combined with the Alberta Seniors Benefit. You will receive one combined payment each month. If a couple is required to live apart for health reasons, a review of eligibility is completed to consider the couple as two single seniors living in separate dwellings.

Provincial Government - Programs

Special Needs Assistance

The benefit year for the Special Needs Assistance for Seniors program starts July 1 of one year and ends June 30 of the following year.

The Special Needs Assistance program for Seniors provides low income financial assistance toward a range of expenses including appliances and specific health and personal supports. A senior's total annual income and the expense requested are used to to determine the amount funded. The maximum assistance available is \$5,105 in a benefit year (July 1-June 30).

Seniors must complete the Seniors Financial Assistance application form to enroll in the program. Once you are notified of your eligibility for Seniors Financial Assistance programs, you can submit an estimate or receipt to apply for assistance towards the cost of an item funded by the program.

Eligible items:

Special Needs Assistance for Seniors considers specific items that fall into one of the following three categories:

- appliances/furniture
- health supports
- personal supports

Your income level determines whether you are eligible for primary or secondary items.

- Be a Canadian Citizen or Permanent resident (landed immigrant) and
- Have an income level within the limits allowed by the program

If you have already applied for Seniors Financial Assistance programs, you are automatically enrolled in the Dental and Optical Assistance for Seniors programs and do not need to reapply.

My Service Canada Account

My Service Canada Account (MSCA) is a secure online portal that lets you apply, view and update your information for Employment Insurance (EI), Canada Pension Plan (CPP), Canada Pension Plan disability and Old Age Security (OAS).

Old Age Security Pension

Your Old Age Security (OAS) can start as early as the month after you turn 65. You should receive a letter from Service Canada advising of automatic enrollment the month after you turn 64 years old.

To be eligible for the Federal OAS pension you must:

- Be at least age 65 (you do not need to be retired)
- Be a legal resident of Canada
- Have lived a minimum of 10 years in Canada after age 18

Old Age Security (OAS) - Spousal Allowance:

- If you are between 60-64 and your spouse or common-law partner is receiving OAS, you may qualify for the allowance to help bridge your income until you turn 65.
- You must apply for this allowance.
- To apply visit your nearest Service Canada Centre.

Federal Government - Programs

Canada Pension Plan (CPP)

The Government of Canada administers the Canada Pension Plan (CPP). You contribute to CPP through employment or self-employment. Applications for CPP are available at any Service Canada Centre.

You are eligible for CPP benefits if you have worked and contributed to the Canada Pension Plan. You can apply as early as 60 years or as late as 70 years of age. You need to apply at least 6 months before you want to receive your CPP retirement benefits.

Disability Benefit

If you become severely disabled to the extent you cannot work at any job on a regular basis, you may receive a monthly Canada Pension Plan Disability benefit.

Survivor's Pension

This monthly pension is paid to the surviving spouse or common-law partner of a deceased contributor.

Death Benefit

The CPP death benefit is a one-time payment to, or on behalf of, the estate of a deceased CPP contributor.

Guaranteed Income Supplement


The Guaranteed Income Supplement (GIS) provides a monthly non-taxable benefit to Old Age Security pension recipients who have low income and are living in Canada.

You qualify for the GIS if you meet all of the following conditions:

- You are receiving an Old Age Security pension
- Your annual income is less than the maximum annual threshold (or, in case of a couple, combined income)
- You must apply for this benefit

Eligibility for GIS is reviewed yearly, using information from your Income Tax and Benefit return. If you still qualify, your benefit will automatically be renewed. In July you will receive a letter advising you if your GIS is renewed, stopped or more information is required.

Affordable Housing

Subsidized Housing Leduc County

Leduc Regional Housing Foundation (LRHF) provides affordable accommodation and services to seniors 65 years and older.

Self-contained apartments or lodge accommodations are available. Apartments are located in Leduc, Devon, Beaumont, Thorsby and New Sarepta. Lodges are located in Leduc and Warburg.

Residents are required to pay 30% of their gross monthly income for rent. To determine eligibility an application form must be completed along with a medical form from a doctor; previous year's tax information and an interview.

Alberta Aids to Daily Living (AADL)

The Government of Alberta offers the Aids to Daily Living (AADL) program to assist with long-term disability, chronic illness, or terminal illness. AADL helps Albertans stay independent in their communities by paying for basic medical equipment and supplies.

To be eligible, a clinical assessment by a health care professional is required. They will determine what equipment and supplies you can get through the AADL program.

AADL is a cost-share program. Albertans pay 25% of the benefit cost to a maximum of \$500 per individual or family per year. Low-income Albertans and people receiving income assistance do not pay the cost-sharing portion.

Protection for Persons in Care

The Protection for Persons in Care office (PPCO) addresses reports of abuse and administers the Protection for Persons in Care Act. This act promotes the safety and well-being of adult Albertans who receive care or support services from publicly funded service providers, including hospitals, seniors' lodges, nursing homes, mental health facilities, shelters, and other supportive living settings. The act requires that all service providers protect clients from abuse and maintain a reasonable level of safety. The act also requires that abuse be reported. A complaint officer reviews every allegation reported.

Home Care Central Intake

AHS provides healthcare services or contracts other home care providers to provide care. A case manager works directly with the client and is responsible for assessing the client's needs, and ensuring the overall coordination of care and services.

Alberta Health provides premium-free coverage for some health-related services not covered by your Alberta Health Care insurance plan (Coverage for Seniors). This coverage is available once you are registered with Alberta Health and you have your Alberta Blue Cross card. To receive services show your card.

Ambulance

Seniors, age 65 and over, enrolled in the Coverage for Seniors program do not receive a bill for EMS. The Alberta government pays the complete cost of ambulance services.

Prescription drugs

Alberta Health covers 70 per cent of the cost of prescription drugs, you are required to pay the other 30 per cent up to a maximum of \$25 per prescription or refill.

Diabetic supplies

Coverage for Seniors provides diabetic supplies for insulin-treated diabetics only, up to a maximum of \$600 per eligible person each benefit year.

Clinical Psychological

Coverage up to \$60 per visit, to a maximum of \$300 per family each benefit year, by a registered chartered Psychologist.

Chiropractic service

Up to \$25 per visit to a maximum of \$200 each benefit year.

Community Geriatric Psychiatric Program

The Community Geriatric Psychiatric
Program works in partnership with seniors to
provide individualized care, to promote
recovery and well being. Collaboration with
primary care physicians, community
agencies, and health and social services
providers is an important part of supporting a
senior's wellness and recovery.

- Psychiatric consultation
- Comprehensive assessment
- Treatment and follow-up in the most appropriate setting
- Addiction screening
- Assessment and counseling services
- Therapeutic group programming.

Continuing Care Services

Contact Alberta Health Services by calling 8-1-1

Alberta's continuing care system provides Albertans with the health, personal care and accommodation services they need to support their independence and qualify of life.

Continuing care services are provided in three streams:

- Home living
- Supportive living
- Long-term care

Individuals looking for continuing care services will undergo a needs assessment by a health-care professional to determine their care and service needs. Anyone can request this assessment. AHS staff will work with the individual and family to find the service or facility that best meet the client's needs.

Home Living/Home Care Services:

The home living stream is designed to support individuals living in their own home. AHS will assess the client at no charge. An assessment can be arranged by contacting Alberta Health Services through Health Link by calling 8-1-1

Supportive Living:

Supported living combines accommodation services with other supports and care. It is designed to assist individuals in maintaining a level of independence and includes seniors lodges, group homes and designated supportive living accommodations.

Designated Supportive Living:

Designated supportive living is a type of supportive living. AHS determines access to designated supportive living and requires individuals to be assessed by a health professional to determine their health needs before they can move in.

Facility Living/Long Term care:

Long term care facilities provide support to individuals who require 24- hour nursing support to meet medical needs associated with chronic disease or frailty. Long term care facility living provides room and board in a secure living arrangement alone with personal care and support with activities of daily living.

Admission to long-term care facilities is determined by Alberta health Services, by conducting an assessment of the individual's health needs. For more information contact Health Link by dialing 811.

Call 9-1-1 immediately if you or someone else has any of these symptoms

- Sudden numbness or weakness in the face, arm, or leg, especially on one side of the body.
- Sudden confusion, trouble speaking, or difficulty understanding speech.
- Suddentrouble seeing in one or both eyes.
- Sudden trouble walking, dizziness, loss of balance, or lack of coordination.
- Sudden severe headache with no known cause.



Estate Planning

Power of Attorney

A Power of Attorney (General Power of Attorney) allows you to plan for the future by appointing someone else to manage your financial affairs while you are still alive.

Granting a power of attorney gives another individual the power to make decisions and act on your behalf. Power of attorney is voluntary and limited to matters of property and finance.

- You must be mentally competent to appoint an attorney
- It takes effect immediately
- It ends if you become mentally incapable of managing your affairs.

Power of Attorney does not give someone authority to make decisions about your health care or personal decisions - for that you need a separate document called a <u>Personal Directive</u>.

Enduring Power of Attorney

Enduring power of attorney specifically states that the power of attorney remains in effect should you become mentally incapable of managing your affairs.

The agreement:

- Is written when you're capable of making your own decisions
- States when the person you trust will have authority
- Can start immediately and continue if you lose capacity
- Can start when you lose capacity

If you lose your capacity and don't have an enduring power of attorney agreement in place, one of your friends or family members might have to go to court to become your trustee. This takes time and money.

Although it is not mandatory, you should contact a lawyer to get this agreement. A lawyer can explain all your agreement options.

Your agreement can include:

- Specific decisions
- Specific dates
- Specific limits
- Multiple people

Mental capacity means the ability to understand information that is relevant to making a decision and the ability to appreciate the reasonably foreseeable consequences of the decision.

Estate Planning

Personal Directive

A Personal Directive is a legal document that allows you to appoint a person or persons (Agent) you trust to make non-financial decisions for you while you are alive but when you do not have the mental ability to make decisions for yourself. The person you appoint as your Agent will be permitted to make decisions for you regarding health care, housing and treatment.

Alberta law does not allow anyone to automatically make decisions for you, not even your spouse or family members. By making a Personal Directive, you are appointing someone to make decisions for you based upon your expressed wishes. You should discuss your wishes with your Agent.

A Personal Directive may only be used once you have been declared mentally incapacitated and is only valid until you die or you are determined to have regained your mental ability. You may include in your Directive who will be responsible for deciding your capacity.

You may contact the office of the Public Guardian to receive a form for creating your Personal Directive, or print the form from alberta.ca/personal directive. You can also register your Personal Directive with the Office of the Public Guardian.

Wills

A Will is a written document that allows you to set out how your property is to be distributed after you pass away.

A Will allows you to name a person to act as your executor after your death and to make certain that your property is distributed according to your wishes. Making a Will is voluntary and optional. Your wishes need to be in writing and must adhere to the specific conditions of the Wills Act (Alberta).

You can have a lawyer draw up your Will, or you can make you own Will by using a kit or downloading forms from the internet.

Grieving is a personal and highly individual experience. How you grieve depends on many factors, including your personality and coping style, your life experience, your faith, and the nature of the loss. There is no timetable for grieving and "getting on with one's life." Grief is a natural reaction to loss and is part of the healing process. Grief can have many stages ranging from shock and disbelief, sadness, guilt, anger and fear, as well as physical symptoms such as fatigue, insomnia, weight loss or weight gain, and aches and pains. However, not everyone who grieves will go through all of these stages prior to reaching a point of acceptance. If you are having difficult time moving forward from your loss, there are many support groups and agencies available to assist families and friends with grieving. Alberta Health Services can refer you to local support groups. Some faith groups provide special services during holiday seasons to support people who are grieving.

Who to notify if there is a death

Agencies often require a copy of the death certificate from the funeral home.

Motor Vehicle

If a vehicle was registered in the name of the deceased person, contact a registry agent o transfer the vehicle's ownership. The agent will need to see the vehicle registration, insurance policy and death certificate. The deceased person's drivers's license needs to be given to the registry agent.

Ensure the name of the deceased is removed from any car insurance by contacting the insurance company.
