## City of Beaumont Notice of Non-Statutory Public Hearing Dansereau Meadows Outline Plan Amendment

## November 5, 2024, 6:00 pm., City Hall 5600 49 Street, Beaumont AB T4X 1A1

An Outline Plan is a non-statutory plan that provides the land use and servicing framework for future subdivision and development within a neighbourhood. Amendments to Outline Plans may be adopted via resolution by Council.

The purpose of this amendment to the Dansereau Meadows Outline Plan is to facilitate relocation of townhouse development from one area of N.W. ¼ SEC. 34-50-24-W4M to two separate areas within the same parcel. This proposal requires relocation of a portion of 'Medium Density Residential' land use to two separate areas within the northern portion of the Dansereau neighbourhood. The area originally designated for 'Medium Density Residential' land use would become 'Low Density Residential'. This proposal requires an update to the Land Use Concept, all maps in the Outline Plan, and the Population Statistics Table. An application to amend Bylaw 944-19 *Our Zoning Blueprint*: Land Use Bylaw is also required to facilitate this townhouse proposal and will be considered concurrently with this Outline Plan Amendment under Bylaw 1061-24.

  register with the City Clerk in advance of the public hearing, but you may also choose to
  register at the public hearing.
- For those wishing to make a presentation by **electronic means**, you must register with the City Clerk by 4:00 pm on the business day prior to the public hearing. Once you register, the City Clerk will provide you with instructions for accessing the meeting and making your presentation.
- Each speaker will be limited to five minutes, not including time for any questions from Council.
- The names of presenters and the written submissions received become part of the
  public record and written submissions are made available for public inspection on the
  City's website. Other personal information is protected by the privacy provisions of the
  Freedom of Information and Protection of Privacy Act.
- Anonymous submissions are not accepted, and an individual's name must be attached to every submission.
